## **Applicants, Project Descriptions, Estimated Costs:**

<u>Seasons Hospice & Palliative Care</u> is proposing to establish a Medicare and Medicaid certified hospice agency in Snohomish County. The address for the new agency is:  $3400 - 188^{\text{th}}$  Street, Suite A24, in Lynnwood [98037]. The estimated capital costs for the project is \$21,968.

<u>Inspiring Hospice Partners of Oregon, LLC</u> is proposing to establish a Medicare and Medicaid certified hospice agency to serve Snohomish County.
