Applicants, Project Descriptions, Estimated Costs:

Seasons Hospice & Palliative Care is proposing to establish a Medicare and Medicaid certified hospice agency in Snohomish County. The address for the new agency is: 3400 –188th Street, Suite A24, in Lynnwood [98037]. The estimated capital costs for the project is \$21,968.
