07-03-2023	<p>Revised first paragraph of Mailer Tracking section (last paragraph on page 22 of 05-05-2022 approved plan) as shown below.</p> <p>All mailers, whether they are distributed from a mail-back distribution location or from the program website and program toll-free number, are shipped back to Covanta for destruction and will have a unique, serialized identification number. Mailers distributed directly to covered entities via the program website or program toll-free phone number requests will be tracked by Inmar when sent to covered entities and tracked through receipt for final destruction at Covanta Inmar's approved DEA Reverse Distributor(s) to final destruction at the destruction facility.</p> <hr/> <p>Revised Mail-Back Envelopes and Packages section (top of page 26 of 05-05-2022 approved plan) as shown below:</p> <p>Mail-Back Envelopes and Packages</p> <p>All Mailers will be received by Inmar's approved DEA Reverse Distributor(s) at Covanta in Indianapolis, IN and will be incinerated on-site transported via common carrier for witnessed incineration at one of Inmar's approved disposal vendors. Inmar's Reverse Distributor(s) has DEA approval to provide destruction of Mailers off-site and a copy of the DEA exception letter has been provided to DOH.</p> <hr/> <p>Added note to Service Provider section (page 26 of 05-05-2022 approved plan) as follows:</p> <p>Note: Each reverse distributor(s) that is approved to receive mailers also holds an exception to Title 21 CFR 1317.70(a) from DEA which permits them to operate a mail-back program absent an on-site method of destruction. Copies of these DEA exception letters are being provided as an attachment.</p> <hr/> <p>Updated Service Provider table to categorized for ease of use. Also updated to current names and added and removed service providers as shown below. Note unhighlighted service providers are new. Yellow highlighting indicates service provider in 05-05-2022 approved plan.</p>	<p>Approved</p> <p>Covanta Environmental Solutions and 123 Compliant Logistics (reverse distributors) are the only service providers that receive mailers.</p> <p>The department received copies of DEA letters granting Covanta Environmental Solutions and 123 Compliant Logistics temporary exemptions from 1317.70(a).</p>

Goals, Collection, 180 days after plan approval is changed as follows:</p> <p>Inmar sets a collection goal (for Collection Sites) of 20 pounds per month per collection site for a total of 3,880 pounds of Covered Drugs collected from 194 Kiosks monthly and 46,500 23,280 pounds in the first 180 days after Plan approval.</p>	<p>Approved plan accurately describes monthly estimated collection amount (3,880 pounds) but inaccurately describes 180 day collection goal as 46,560 rather than 23,280 pounds. 180 days is approximately six months. 3,3880 multiplied by 6 equals 23,280.</p>
