### 1. CALL TO ORDER

#### 1.1 Introductions

#### 1.2 Reasonably safety determination for meetings

The committee moved and made a determination to host hybrids meetings throughout 2023. The meetings will offer a public space as well as offering a virtual option. The factors considered for offering virtual meetings were the high levels of transmission on COVID in the community, inability to social distance in available facilities, and the lack of ability to enforce masking for the public.

# 1.5 Public comment opportunity

# 2. PRESENTATION ON DEPARTMENT OF TRANSPORTATION MED PREF PROGRAM – The committee received a presentation on the Washington State Department of Transportation Medical Preferential Loading program by Zale Noah.

Washington State Department of Transportation (WSDOT) Medical Preferential Load program provides exemption from the standard "first-come first-served" policy when a customer has a medical condition where an extended wait on the dock would cause detrimental risks to their health.

WSDOT has been developing the online format of the Medical Preferential Loading program to improve efficiency and sustainability. The online format is projected to rollout in early 2023 as a designated webpage on the WSF website, replacing the current system of faxing the applications to ferry terminals. Current applications authorize preferential loading for 90 days, which will be decreasing to 30 days, with an added option for travelers with chronic or long-term conditions to apply for an annual permit. More updates will follow as WSDOT rolls out the program updates.

#### 3. PRESENTATION ON DEPARTMENT OF HEALTH DISCIPLINE PROCESS

Lydia Koroma, Supervising Staff Attorney, Office of Investigative and Legal Services presented information to the committee on the disciplinary process. The presentation



included information on the authorization and investigation process as well associated timelines. Ms. Koroma also included information regarding the Uniform Disciplinary Act (UDA).

- **RULES WORKSHOP** The committee briefly discussed rules relating to SSB 5765 which allows for licensing extensions for limited prescriptive authority and medical devices and implants. Ms. Weed will continue working on the draft language and opportunities to provide input will happen in future months.
- **PROGRAM MANAGER UPDATE** Information provided to the committee for possible action by Kathy Weed, Program Manager.
