**NEW SECTION 246-924-002 COVID-19**

The following exemptions apply to applicants who completed training between February 29, 2020 through June 30, 2025 regardless of when they apply for licensure:

(1) Telehealth: Supervised experience completed through telehealth during this time period is considered as fulfilling the direct experience or direct client contact requirement under WAC 246-924-053, WAC 246-924-056, and WAC 246-924-057.

(2) Telesupervision: Virtual supervision completed during this time period is considered as fulfilling the face-to-face individual supervision requirement under WAC 246-924-053, WAC 246-924-056, and WAC 246-924-057.

**NEW SECTION 246-924-003 Telehealth standards**

(1) General practice for a provider using telehealth:

(a) Provider must take reasonable steps to ensure they are competent with both the technologies used and the potential effect of the use of telehealth on clients.

(b) Providers must obtain and document informed written consent and verbal assent that specifically addresses the concerns that may be related to the telehealth services they provide. Such informed consent should be developed so it is reasonably understandable to clients. Informed consent may include, but is not limited to:

(i) The manner in which the provider and client will use particular telecommunications technologies, the boundaries that will be established and observed, and procedures for responding to electronic communications from clients; and

(ii) Issues and potential risks surrounding confidentiality and security of client information when particular telecommunication technologies are used (e.g., potential for decreased expectation of confidentiality if certain technologies are used).

(c) When providing care or treatment to a client through telehealth, a provider shall use technology that is compliant with the Health Insurance Portability and Accountability Act (HIPAA).

(2) Telehealth for individuals working towards licensure: There is no predetermined limit on the number of telehealth hours that can be counted towards supervised experience hours.

(a) A doctoral program and supervisors must ensure the supervised experience includes the minimum face-to-face interaction.

(b) The minimum amount of face-to-face interaction is determined for each category of supervision under WAC 246-924-053, WAC 246-924-056, and WAC 246-924-057.

#### **246-924-030 Guidelines for the employment and/or supervision of auxiliary clinical staff.**

(1) Qualifications of the supervisor: The supervisor shall be licensed in Washington state for the practice of psychology and have adequate training, knowledge, and skill to evaluate the competence of the work of the auxiliary staff. The supervisor may not be employed by the auxiliary staff.

(2) Qualifications of the auxiliary staff: The staff person must have the background, training, and experience that is appropriate to the functions performed. The supervisor is responsible for determining the adequacy of the qualifications of the staff person and the designation of their~~his/her~~ title.

(3) Responsibilities of the supervisor: The supervisor accepts full legal and professional responsibility for all services that may be rendered by the auxiliary staff. To this end, the supervisor shall have sufficient knowledge of all clients, including face-to-face contact when necessary, in order to plan and assure the delivery of effective services. The supervisor is responsible for assuring that appropriate supervision is available or present at all times. The supervisor is responsible for assuring that auxiliary staff are informed of and adhere to requirements of confidentiality. The supervisor shall assure that the staff person providing services is appropriately covered by professional liability insurance and adheres to accepted business practices.

(4) Conduct of supervision: It is recognized that variability in preparation for duties to be assumed will require individually tailored supervision. In the case of auxiliary staff providing psychological services, a detailed job description shall be developed and a contract for supervision prepared.

(5) Conduct of services that may be provided by auxiliary staff: Procedures to be carried out by the auxiliary staff shall be planned in consultation with the supervisor. Clients of the auxiliary staff shall be informed as to his/her status and shall be given specific information as to his/her qualifications and functions. Clients shall be informed of the identity of the supervisor. They shall be informed that they might meet with the supervisor at their own request, the auxiliary staff person's or the supervisor's request. Written reports and communications shall be countersigned by the supervisor.

An "academic residency" is a residency that exists for the purpose of acculturation in the profession involves the full participation and integration of the individual in the educational and training experience and includes faculty-student interaction.

An applicant who chooses to complete an academic residency must complete at least a one-year continuous full-time academic residency at the institution that grants the doctoral degree. The applicant must be physically present, in-person at the educational institution providing the residency and granting the doctoral degree.

"Continuous" means full-time enrollment over the course of the defined academic year. Multiple long weekends or summer intensive sessions do not meet the definition of continuous.

#### NEW SECTION 246-924-048 Educational meetings

To meet the doctoral degree program requirement in WAC 246-924-046(1)(b) an applicant may choose to complete educational meetings or an academic residency under WAC 246-924-047. Educational meetings are graduate-level classes, courses, seminars, or symposia that are substantially related to acquiring academic knowledge and clinical skills related to psychology.

(1) An applicant who chooses to complete educational meetings must complete a minimum of five-hundred hours of educational meetings involving student-faculty contact and face-to-face individual or group interaction.

(b) Be conducted by the psychology faculty of the institution at least seventy-five percent of the time. Faculty means direct employees of the institution, contractors, guest speakers or lecturers authorized by a faculty member.

(c) Be fully documented by the institution and the applicant;

(d) Relate substantially to the program components specified;

(e) Be substantially related to acquiring the academic knowledge and clinical skills essential to successfully practicing clinical psychology after graduation; and

(f) Be documented on an academic transcript including graduate-level classes, courses, seminars, or symposia.

(3) The doctoral program must provide directly to the board on the program's letterhead the following information about every component of each educational meeting:

The board's interpretation of this statement is that a holder of a certificate of qualification, referred to as a "psychological assistant," is certified *in tandem* with a licensed psychologist and not in his or her own right. The board will evaluate, at the same time, the professional capabilities of the certificate of qualifications applicant, and the qualifications of the licensed psychologist to supervise the psychological assistant in the specific professional functions outlined by the psychological assistant. The board must examine and approve the professional qualifications of the psychological assistant applicant and the licensed psychologist and their supervisor-supervisee agreement. The board does not approve specific work conditions, fees, salaries, and related factors as relevant to the nature and quality of the professional relationship or services offered to the public.

An applicant for a psychological associate license or a licensed psychological associate must practice under supervision consistent with their level of education:

(1) Level 1: As a student currently enrolled in a doctoral program participating in a practicum, supervision must comply with WAC 246-924-053;

(2) Level 2: As a student currently enrolled in a doctoral program participating in an internship, supervision must comply with WAC 246-924-056 or WAC 246-924-057; or

(3) Level 3: As a postdoctoral graduate, supervision must comply with WAC 246-924-059.

(2) The applicant must indicate on the application form, in detail, his or her areas of intended practice. After initial screening (evaluation of the person's education, experience, and supervision) and passing the written examinations, the applicant shall furnish the board with a plan for continued supervision, which will include detailed information regarding the supervisor, which indicates an agreement to supervise.

(3) Minimum supervision shall include discussion of the psychological assistant's work through regularly scheduled contacts with the supervisor at appropriate intervals. Whenever possible, supervision should consist of occasional direct observation or review of recorded case material. The supervisor shall be responsible for preparing evaluative reports of the psychological assistant's performance, which will be forwarded to the board on a periodic basis.

(4) When a licensed psychologist assumes the responsibility of supervision, he or she shares the professional and ethical responsibility for the nature and quality of all of the psychological services the psychological assistant may provide. Failure to provide supervision as described in the agreement may result in appropriate action against the license of the supervisor.

(5) Interruption or termination of a supervisory relationship shall be promptly communicated to the board by the supervisor or the psychological assistant.

(6) In every case where psychological testing is done and a report is written based on that testing by a psychological assistant, the supervising licensed psychologist will countersign the report indicating his or her approval.

(1) Each client of the psychological assistant or psychological affiliate must be informed of the nature of the assistant's or affiliate's professional status, the function in which he or she is certified, and the fact that said assistant is under the supervision of a licensed psychologist.

~~(2) Only psychological affiliates may advertise their services (e.g. representations of themselves in telephone directories and announcements and on business cards). In doing so, the affiliate must list the functions for which he or she is certified and state his or her academic degree.~~

#### **Continuing Education**

##### **246-924-230 Continuing education requirements.**

(1) To renew a license, a licensed psychologist shall complete at least 60 hours of continuing education (CE) every three years, including a minimum of:

(a) Four hours in ethics. Areas to be covered, depending on the psychologist's primary area(s) of function are practice, consultation, research, teaching, or supervision.

(b) Two hours in health equity. Qualifying trainings must meet the standards in WAC 246-12-830.

(c) Six hours in suicide prevention, every six years. Qualifying trainings must meet the standards in WAC 246-924-255 and be listed on the department's model list.

### **Rules of Ethical Conduct**

#### **246-924-353 Competence.**

(1) Limits on practice. The psychologist shall limit practice to the areas in which ~~he/she is~~they are competent in. Competency at a minimum must be based upon appropriate education, training, or experience.

(2) Referral. The psychologist shall refer to other health care resources, legal authorities, or social service agencies when such referral is in the best interest of the client.

### **Temporary Permit and Other Limited Credentials**

#### **246-924-480 Temporary permits.**

(1) Temporary permits are:

(a) Issued under RCW [18.83.082](#); and

(b) Valid for no more than ninety days within one calendar year from the date they are issued.

(2) If the board finds that another state's licensing requirements are deemed not equivalent because a stated requirement is omitted or deficient, the applicant is not eligible for the temporary permit unless the applicant demonstrates proof of graduation from an APA- or CPA-accredited doctoral program and successful completion of an APA-, APPIC-, or CPA-approved internship.

(3) There is no charge for a temporary permit.

(4) Candidates applying for a temporary permit must:

(a) Verify that ~~he or she is~~they are credentialed to practice psychology in another state that has been deemed substantially equivalent by the board, or is a member of an organization listed in WAC [246-924-100](#)(3); and

(b) Submit a completed application on a form provided by the board.
