## Open Session:

- 1. Call to Order and Introductions Melissa Dacumos, OD, Chair
  - Dr. Dacumos called meeting to order at 9:03 am.
- 2. Approval of agenda

October 11, 2024, meeting agenda was moved, seconded, and approved.

- 3. Approval of minutes
  - June 14, 2024, meeting minutes were moved, seconded, and approved.
- 4. Rules Hearing The board will consider public comment and the adoption of proposed rules for
  - **4.1.** Board of Optometry, Continuing Education, Chapter 246-851 WAC Jurisprudence Examination.

In order to comply with Section 8 of Second Substitute House Bill (2SHB) 1724 (chapter 425, Laws of 2023) codified as RCW 18.130.077 and reduce barriers for optometrist to enter and remain in the health care workforce, the Board of Optometry (board) filed WSR 24-06-033 on February 28, 2024 proposing to move the jurisprudence (JP) exam required for initial licensure in Washington State to an optometrists first full continuing education (CE) reporting period.

- **4.1.1.** This rule was open to testifying, no comments were made, and comments were closed.
- **4.1.2.** A motion to approve was moved, seconded, and approved. Roll call vote was called for and all member unanimously approved by:

- **4.2** Board of Optometry, Advanced Procedures Endorsement, Chapter 246-851 WAC. The board is proposing to amend and establish new sections in chapter 246-851 WAC to implement Substitute Senate Bill (SSB) 5389 (chapter 400, laws of 2023), which expands the optometrist scope of practice. The board filed WSR 23-16-043 on July 25, 2024, to open rules to make the required legislative changes.
  - **4.2.1.** This ruling was opened to testifying at 9:21 am.

Dr. Stephanie Cramer testified, she represents the Washington Academy of Eye Physicians and Surgeons and the Washington State Medical Association. Dr. Cramer is opposed to this rule being written. Concerns for a weekend CME course to replace hands on training and schooling. Dr. Cramer stated that in the subcommittee meetings, she had really encouraged the Board of Optometry (board) to make that requirement more stringent so that optometrists can get the training they need on these procedures because they are so varied.

Written testimony was received from the Washington Academy of Eye Physicians and Surgeons, as well as the Washington State Medical Association. There concerns were echoed through the testimony Dr. Cramer's gave today.

No additional testimonies were received, and comments were closed at 9:29 am.

**4.2.2.** A motion to approve was moved, seconded, and approved. Roll call vote was called for and all member unanimously approved by:
