



WEMSIS Documentation Guidance: Flowcharts for select situations

This document provides guidance on how to document NEMSIS reports for select situations. The guidance below includes suggested entries for these situations, such as when a call is cancelled, when a lift assist is needed, or when a patient has died on scene. EMS services may reach out to their software vendor for options to streamline documentation of these situations.

The suggested entries below were derived from similar flowcharts or the extended data definitions created by NEMSIS. However, the needed documentation may differ depending on the circumstances of the EMS response, or local protocols and definitions. For example, in situation #7 a provider's impression of Cardiac Arrest is suggested, though any other applicable entry may be suitable.
