

# Health Profession Licensing & Regulation December 2016

The Health Professions Account, established in RCW 43.70.320, supports the work of licensing and regulating all health practitioners in Washington helping to ensure patient safety. The Secretary of Health in partnership with five commissions and 12 boards carry out the regulation of health practitioners. Each health profession's practitioners pay initial and renewal licensing fees to support the regulation of each profession.

#### Services


- Regulating more than 430,000 credentialed practitioners in 86 professions.
- Each year, the Department of Health:
  - o Reviews more than 70,000 licensure applications; issues and renews licenses.
  - Supports 100 board and commission meetings.
  - o Receives more than 20,000 public disclosure requests.
  - o Receives nearly 10,000 complaints from the public.
  - o Investigates more than 4,000 complaints about health practitioners.
  - o Issues more than 1,000 legal orders.
  - o Updates more than 50 rules, with more than 100 in process.
  - o Analyzes 200 to 230 pieces of proposed legislation.
  - o Prepares more than 100 fiscal notes.
