Dear Dr. Slack:

The Department of Health has completed its review of the Everett Clinic, PLLC Determination of Reviewability Ambulatory Surgery Center/Facility (ASF) request. You represented in your determination of reviewability request that:

- The Everett Clinic, PLLC is a professional limited liability company governed by DaVita Everett Physician, Inc. PS.
- Shawn Slack, MD is the sole owner and shareholder of DaVita Everett Physician, Inc. PS.
- The Everett Clinic, PLLC clinical practice and surgical facility are located at the same physical address: 21401 - 72<sup>nd</sup> Avenue West, Edmonds, WA 98026.
- The Everett Clinic, PLLC clinical practice and surgical facility are under single ownership and would be operated under the corporation and Unified Business Identifier [UBI] #313 001 098; and FEIN #91-0214500
- Income derived from surgical services provided at the Everett Clinic, PLLC is approximately 45.2% of total revenue generated by the ASF.
- Patient visits that are for surgical services provided at the ASF are approximately 24.3% of the total patient's visits to the ASF.
- Future owners or employees may have access to the ASF. A listing of specific physicians credentialing information and practice associated with the ASF is on file.
- The Everett Clinic, PLLC has three operating rooms.
- The Everett Clinic, PLLC will not be operated as a separate legal entity from the Everett Clinic, PLLC practice.
- Clinical and surgical services provided at the Everett Clinic, PLLC are orthopedics, otolaryngology, physical therapy, spine physiatry; and advanced imaging.
- Everett MSO, Inc. will provide administrative services at DaVita Everett Physician, Inc. PS a management agreement was provided.

### **CONCLUSION**

Based on the totality of information presented in the application and resulting research, the department concludes the Everett Clinic, PLLC does not require a Certificate of Need. This decision is not transferable.

### **CHANGES THAT MAY EFFECT THIS DECISION**

If changes are made in the operation or ownership the Everett Clinic, PLLC may no longer qualify for this decision. In that case, prior Certificate of Need review and approval or new determination of reviewability request would be required.

### **APPEAL OPTION**

This decision may be appealed. You or any person with standing may request an adjudicative proceeding to contest this decision within 28 calendar days from the date of this letter. The notice of appeal must be filed according to the provisions of Revised Code of Washington 34.05 and Washington Administrative Code 246-310-610. A request for an adjudicative proceeding must be received within the 28 days at one of the addresses listed on the following page.


