Dear Dr. Fisk

The Department of Health has completed its review of Acute Pain Management, PLLC Determination of Reviewability Ambulatory Surgery Center/Facility (ASF) request. The application proposes to relocate an existing, two operating room, ASF in Bellevue to a new site that is also in Bellevue. You represented in your determination of reviewability request that:

- Acute Pain Management, PLLC is a professional limited liability corporation.
- Zachary Fisk, MD is the sole owner and sole member of Acute Pain Management, PLLC.
- Acute Pain Management, PLLC clinical practice and surgical facility current address is: 1310 116<sup>th</sup> Avenue NE, Suite A Bellevue, WA 98004.
- Upon relocation, Acute Pain Management, PLLC clinical practice and surgical facility address would be located at: 13033 Bel-Red Road, Bellevue, Washington 98005.
- Acute Pain Management, PLLC clinical practice and surgical facility address would be operated under the Unified Business Identifier [UBI] #604 004 648; and FEIN #81-3123328.
- Income derived from surgical services at Acute Pain Management, PLLC would be approximately 35% of total revenue generated by the ASF.
- Patient visits income that is for clinical services provided by the ASF is approximately 65% of the total income generated at the ASF.
- Future owners or employees have access to the ASF.
- Acute Pain Management, PLLC has two operating rooms.
- Acute Pain Management, PLLC will not be operated as a separate legal entity from Acute Pain Management, PLLC practice.
- Clinical and surgical services provided at Acute Pain Management, PLLC typically include those associated with interventional pain management.

### CONCLUSION

Based on the totality of information presented in the application and resulting research, the department concludes Acute Pain Management does not require a Certificate of Need. Under this determination, Acute Pain Management is authorized to provide pain management procedures in two operating rooms.
