# Bright Futures in Practice: Oral Health

- Informs families and health professionals about topics such as dental caries, tobacco use, and injury.

- Helps professionals develop and implement oral health programs.

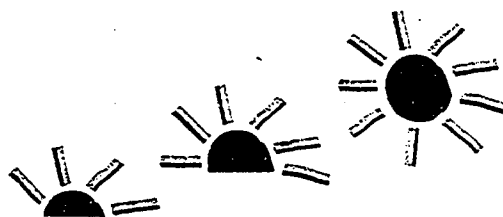
## Oral Health Supervision Periodicity and Services

### Dental Health Professionals

- Recommend that children and adolescents visit the dentist's office or clinic every 6 months, or as indicated by the child's needs and/or susceptibility to disease, as determined by a primary care dentist.

### Health Professionals

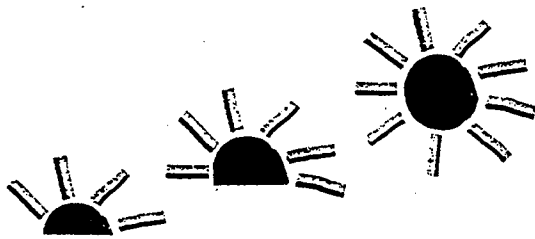
- Can reinforce oral health supervision within the context of health supervision visits.



Taking the lead from the *Bright Futures* guidelines, this document emphasizes the opportunity for partnership between dental professionals, other health professionals, and families. It presents specific guidelines, strategies, and tools that dentists, physicians, nurses, dental hygienists, educators, and child care providers can apply in their work.

Other publications in the *Bright Futures in Practice* series will include *Bright Futures in Practice: Nutrition*, *Bright Futures in Practice: Mental Health*, and *Bright Futures for Families*. These materials will provide specific health promotion/disease prevention guidelines and will foster multidisciplinary partnerships.

As we build *Bright Futures* together, the *Bright Futures in Practice* volumes will serve as guidelines for those in the field, as curricula for those entering the field, and as benchmarks for those concerned about the well-being of children.

*Oral Health Examination Survey Manual* - This manual is a supplement to *Assessing Oral Health Needs: ASTDD Seven-Step Model*. It is intended for those programs with sufficient resources to engage in the most costly and labor-intensive oral health needs assessment method, an oral health examination survey.

The manual describes step-by-step procedures for conducting a survey covering topics such as sample selection, survey logistics, equipment and supplies, personnel, training and infection control. Sample forms and references are included.
