Important Social Security Number Information:

If you have a Social Security Number, the law requires you to disclose it on your application for a professional or occupational license. <u>42 U.S.C. § 666(a)(13)</u>; <u>RCW</u> <u>26.23.150</u>. It will be used under the state's child support enforcement program to locate individuals for purposes of establishing paternity and establishing, modifying, and enforcing support obligations. You are not required to have or obtain a Social Security Number to apply for or obtain a license from the Department of Health. If you do not have a Social Security Number, you are still eligible to apply for and obtain a credential if you meet the requirements. Application Instruction Checklist

Important background check information: Washington State law authorizes the Department of Health to obtain fingerprint-based background checks for licensing purposes. This check may be through the Washington State Patrol and the Federal Bureau of Investigation (FBI). This may be required if you have lived in another state or if you have a criminal record in Washington State. This would be at your own expense.

All information should be printed clearly in blue or black ink. It is your responsibility to submit the required forms.

Application Fee: (This fee is non-refundable). You can check the online fee page for current fees.

Request for Military Training and Experience Evaluation Spouse or Registered Domestic Partner of Military Personnel

1. Demographic Information:

Social Security Number: You must list your social security number on your application. You are not required to have or obtain a Social Security Number to apply for or obtain a license from the Department of Health. Please see the <u>Declaration of No Social Security Number Form</u>. Please call the Customer Service Center at 360-236-4700 if you do not have one.

National Provider Identifier Number (NPI): The National Provider Identifier (NPI) is a standard unique identifier for health care professionals available from the Federal Centers for Medicare and Medicaid Services. The NPI is a 10 digit numeric identifier. If you have a NPI number, provide this on your application.

Legal Name: List your full name: first, middle, and last.

Definition of Legal Name: "Legal name" is the name appearing on your official certificate of birth or, if your name has changed since birth, on an official marriage certificate or an order by a court. The court must have legal authority to change your name. We may ask you to prove your legal name. If you use any name other than your legal name on this form, your application may be denied.

Birth date: Provide the month, day, and year you were born.

Address: List the address we should use to send any information about your certification. Be sure to include the city, state, zip code, county, and country. This will be your permanent address with Department of Health until we have been notified of a change, See <u>WAC 246-12-310</u>.

Phone, Fax and Cell Numbers: Enter your phone, fax and cell numbers, if you have them.

Email: Enter your email address, if you have one.

Other Name(s): Indicate whether you are known or have been known under any other names. If you have a name change, you must notify the Department of Health in writing. You must include proof of this change. See <u>WAC 246-12-300</u>.

2. Personal Data Questions:

All applicants must answer the same personal data questions. They are focused on your fitness to practice the essential skills of this profession.

If you answer "yes" to any questions in this section, you must provide an appropriate explanation. You must provide the documentation listed in the note after the questions. If you do not provide this, your application is incomplete and it will not be considered.

- Question 5 includes misdemeanors, gross misdemeanors and felonies. You do not have to answer yes if you have been cited for traffic infractions. You can obtain copies of court records through the county courthouse where the conviction, plea, deferred sentence, or suspended sentence was entered.
- If you have been granted certificate(s) of restoration of opportunity, please provide a certified copy of each certificate.
- Another jurisdiction means any other country, state, federal territory, or military authority.

3. Proof of Employment:

You must be currently employed as a law enforcement officer, police officer or be employed at a detention or correction facility. You must sign and date this as certification of employment. If your employment status changes, you must notify the department within 30 days.

4. Phlebotomy Training and Education

List the forensic phlebotomist training program that you have completed as described in <u>WAC 246-827A-0030</u>.

5. Experience:

List in date order your professional work experience. Attach additional pages if you need more space.

6. Other License, Certification, or Registration:

List all states, including Washington, where credentials are or were held. Attach additional completed pages if you need more space. You must also print the <u>Verification Form</u> and provide it to each state or jurisdiction that you have listed, requesting that they complete and submit the form directly to the Department of Health.

7. Applicant Attestation and Signature:

You must sign and date this for us to process the application.

For Spouses and Registered Domestic Partners of Military Personnel Being Transferred or Stationed in Washington:

Under state law, if you are the spouse or state-registered domestic partner of a servicemember of any branch of the U.S. Military, to include Guard or Reserve, and are applying for a health care professional credential in this state, you may be eligible to have the processing of your application expedited to receive your credential more quickly.

Documents to submit with your application should include the following:

- A copy of your spouse's or registered domestic partner's military transfer orders to Washington State.
- One of the following:
 - A copy of your marriage certificate to show proof of marriage; or
 - A copy of a state's declaration or registration showing you are in a state registered domestic partnership with a member of the U.S. military.

For Current and Former Servicemembers Requesting Evaluation of Military Training and Experience

Under state law, your military education, training, and experience may count towards attaining certain civilian health care profession credentials in Washington State.

Submitted information will be reviewed by the Department of Health to determine substantial equivalency for meeting the credentialing requirements in this state.

Documents to submit with your health care professional credential application should include the following:

 If applicable, a copy of your DD214 Certificate of Release or Discharge from Active Duty, Member-4 or service 2 copy, or NGB-22 for National Guard.

Please note:

- A copy of your DD214 can be downloaded from the EBenefits website.
- You can request a replacement copy of your NGB-22 on the <u>National Archives website</u>.
- Official Joint Service Transcript (JST) or Community College of the Air Force(CCAF) Transcripts.

Please note:

- JST can be sent electronically by visiting the <u>JST website</u> and selecting Washington State Department of Health.
- CCAF transcripts cannot be sent electronically. See the <u>CCAF website</u> for transcript information.
- Verification of Military Experience and Training (VMET) or DD Form 2586. See the <u>DoDTAP website</u>.
- If applicable, application for the Evaluation of Learning Experiences During Military Service (DD Form 295). See the <u>Military Resources website</u>.



Credentialing Requirements

Thank you for applying to become a forensic phlebotomist in Washington State. In order to qualify for certification you must complete the following.

Complete and submit the application, with a original signature, date, and <u>fee</u>.

Education and Training:

- a. Successful completion of a forensic phlebotomy program through a postsecondary school or college accredited by a regional or national accrediting organization recognized by the U.S. Department of Education. Have your accredited post secondary school or college mail your phlebotomy program official transcripts directly to the Department with the date of completion listed. Or;
- b. Successful completion of a forensic phlebotomy training program administered by a health care practitioner, as defined under <u>RCW 18.360.010</u>, whose scope of practice includes venipuncture, and who is responsible for determining the content of the training and for ensuring the proficiency of the trainee. Or;
- c. Military training or experience satisfies the training or experience requirements unless the secretary determines that the military training or experience is not substantially equivalent to the standards of this state. Provide official transcripts showing proof of your education, training, and experience.
- Out-of-State Credential Verification form sent to each state where you hold or have held a credential. The state will complete its portion of the verification form and mail it directly back to Washington State.

Note: You may not practice as a forensic phlebotomist without a valid credential.
